MANDATORY STATE BAR OF ARIZONA ANNUAL FEES ARE CURRENTLY \$475 AND INCREASING TO \$520 BY 1/1/18

This is currently higher than 70% of combined court registration and voluntary membership fee jurisdictions.

By Jan. 1, 2018, Arizona Bar fees will exceed 83% of combined registration and voluntary dues.

Arizona's Bar fees would be higher than all but Colorado and Massachusetts but for Connecticut's \$945 total fee which includes a \$565 state professional privilege tax. Tennessee's \$865 total fee includes a state \$400 occupational tax.

Illinois combined court fees and voluntary bar dues total \$702 but voluntary bar membership includes 15 free CLE hours.
